Press Briefing – Update on the implementation of the immediate and unconditional ceasefire agreement between Cambodia and Thailand

7:00 AM, August 10, 2025

Keynote Address by H.E. Chum Sounry, Spokesperson for the Ministry of Foreign Affairs and International Cooperation (MoFAIC):

The Ministry of Foreign Affairs and International Cooperation firmly rejects the statement issued by the Thailand Ministry of Foreign Affairs on 9 August 2025, which alleges that Cambodia planted new landmines. The Cambodian Mine Action and Victim Assistance

Authority has already provided a clear explanation in its press release on 9 August 2025, refuting this unfounded accusation. To date, no credible or transparent investigation has been conducted into the incident cited by the Thai side.

Cambodia calls for restraint and for the avoidance of premature public accusations, which risk undermining mutual trust and eroding the spirit of ceasefire at a time when constructive engagement is urgently needed. Cambodia urges Thailand to fully honour the commitments reached at the recent extraordinary meeting of the Cambodia-Thailand General Border Committee, in particular the agreement to maintain current troop positions and refrain from movements or patrols toward the other side's positions.

Intervention by H.E. Pen Bona, Royal Government Spokesperson:

As the Spokesperson for the Royal Government of Cambodia, I'd like to reiterate to our fellow citizens that the peace-loving international community is closely observing the ongoing implementation of the ceasefire between Cambodia and Thailand. As the Spokesperson for the Ministry of National Defense, [H.E. LTG. Maly Socheata] has

previously stated, a working group of foreign military attachés has once again travelled to the border provinces. Recently, these affected areas have also been visited by the Interim Observer Team, together with representatives of the diplomatic corps and military attachés from foreign embassies accredited to the Kingdom of Cambodia.

Therefore, the implementation of the ceasefire agreement is under the close and vigilant monitoring of the international community, particularly three key nations—the United States, China, and Malaysia. I wish to reaffirm to our fellow citizens that Cambodia has fully and strictly honored this ceasefire, and we trust that no party will undermine this agreement. In this regard, I call upon our people to place their confidence in the steadfast leadership that remains firmly committed to peace. Cambodians across the nation cherish this hard-earned peace, which reflects the shared aspirations of the international community. I emphasize this to ensure that Cambodians, both at home and abroad, remain assured and steadfast in their confidence in the Royal Government and our leaders.

Keynote Address by H.E. LTG. Maly Socheata, the Ministry of National Defense Spokesperson:

This morning I would like to provide some updates following the entered into force of the ceasefire between Cambodia and Thai armed forces on July 28, 2025, and after the extraordinary meeting of the GBC was concluded on August 7, 2025, until today.

Starting from midnight on 10 August 2025 up to 6 a.m. this morning, the situation at the frontline along the Preah Vihear and Oddar Meanchey provinces remained calm and steady. Cambodian military forces stand strong and fully vigilant in fulfilling their duty. On Sunday, August 10, 2025, the Military Attaché Corps Phnom Penh (MACPP), comprising 14 participants from nine countries, including Australia, the United Kingdom, Canada, China, France, Japan, South Korea, Laos, and Vietnam, with residents both in and outside Cambodia, to depart from Phnom Penh for Oddar Meanchey province to inspect the actual situation and refugee location following Cambodia's full implementation of the ceasefire. The program was coordinated by Lieutenant General Phat Vibol Sopheak, Deputy Director General of the General Department of Politics and Foreign Affairs and Director of the International Relations Department at the Ministry of National Defense, together with many other military officers from the Ministry of National Defense and the Army, to ensure the smooth execution of the mission.

It is worth noting that this mission stemmed from the outcome of the special meeting held on July 28, 2025, in Putrajaya, Malaysia, at the extraordinary meeting of the Cambodia-Thailand General Border Committee (GBC), which reaffirmed the full implementation of the ceasefire agreed upon on July 28, 2025, in Putrajaya. Cambodia reaffirmed its commitment to work constructively in good faith and in close cooperation with Thailand, Malaysia, other ASEAN member states, and all relevant partners to ensure the effective and full implementation of the ceasefire and to resolve all disputes peacefully in accordance with international law and the United Nations Charter and the ASEAN Charter. In this spirit, Cambodia hopes that Thailand will immediately release and return the 18 captured Cambodian soldiers, reflecting the growing appeal from partner countries and international organizations.

Starting from July 29, 2025, at 7.50 am, immediately after the ceasefire entered into force, Cambodian military personnel were unlawfully captured by the Thai soldiers. As of now, there have been almost 12 days as of August 10, 2025. Cambodia has repeatedly urged Thailand to promptly return all 18 military personnel back to Cambodia in accordance with international humanitarian law and in response to urgent appeals from various partner countries and international organizations.

The Ministry of National Defense, the Royal Cambodian Armed Forces, and the international community will continue to call upon Thailand to fulfill its obligations under international law. We are committed to ensuring that no military personnel are left behind or abandoned. Our stance remains firm in advocating for an immediate release and safe return of our detained personnel, emphasizing adherence to legal and humanitarian standards.

11:00AM, August 10, 2025

Keynote Address by H.E. LTG. Maly Socheata, the Ministry of National Defense Spokesperson:

This morning, I would like to provide some updates following the entered into force of the ceasefire between Cambodia and the Thai Armed Forces on July 28, 2025, and after the extraordinary meeting of the GBC was concluded on August 7, 2025.

From 6:00 AM to 10:00AM on 10 August 2025, the situation at the frontline along the Preah Vihear and Oddar Meanchey Provinces remained calm and steady. Cambodian military forces stand strong and fully vigilant in fulfilling their duty.

On the afternoon of Sunday, 10 August 2025, the delegation of the Military Attaché Corps of Phnom Penh (MACPP), comprising both resident and non-resident members, will conduct an on-site inspection of locations that had been directly damaged by indiscriminate airstrikes, MK-84 bombs, and air artillery shelling by the Thai Armed Forces. This attack targeted Cambodian civilian homes, schools, and health centers during the course of the Cambodia-Thai border conflict in the Thmor Doun village, Kukmorn commune, Banteay Ompel district, Oddar Meanchey Province.

It is worth noting that this mission stemmed from the outcome of the special meeting held on July 28, 2025, in Putrajaya, Malaysia, and the extraordinary meeting of the Cambodia-Thailand General Border Committee (GBC) was conducted on August 7, 2025, which reaffirmed the full implementation of the ceasefire agreed upon on July 28, 2025, in Malaysia.

Starting from July 29, 2025, at 7:50 AM, immediately after the ceasefire entered into force, Cambodian military personnel were unlawfully captured by Thai soldiers. As of now, there have been 12 days, 3 hours, and 10 minutes, counting precisely as of 11:00 AM on August 10, 2025. Cambodia has repeatedly urged Thailand to promptly return all 18 military personnel back to Cambodia in accordance with international

humanitarian law and in response to the urgent appeals from various partner countries

and international organizations.

The Ministry of National Defense, the Royal Cambodian Armed Forces, and the

international community will continue to call upon Thailand to fulfill its obligations under

international law. We are committed to ensuring that no military personnel are left

behind or abandoned. Our stance remains firm in advocating for the immediate release

and safe return of our detained personnel, emphasizing adherence to legal and

humanitarian standards. Cambodia would like to reiterate its unwavering commitment

to respecting and strictly implementing all the terms of the ceasefire agreement, as well

as the spirit and content reached at the extraordinary meeting of the GBC on 7 August

2025.

3:00PM, August 10, 2025

Keynote Address by H.E. LTG. Maly Socheata, the Ministry of National Defense Spokesperson:

This afternoon, I would like to provide some updates following the entered into force of the ceasefire between the Cambodian and Thai armed forces on July 28, 2025, and after the extraordinary meeting of the GBC was concluded on August 7, 2025.

From 10:00 AM to 2:00 PM on 10 August 2025, the situation at the front line along Preah Vihear and Oddar Meanchey Province remained calm and steady. Cambodian military forces stand strong and fully vigilant in fulfilling their duty. This afternoon, the delegation of the Military Attaché Corps of Phnom Penh (MACPP), both residents and non-residents, conducted a field inspection of the area affected by the armed conflict, including civilians and civilian objects.

The observation concluded a religious site, Ta Moan Senchey Pagoda, town centre, primary school, gas station, and civilian residential area, which were severely damaged as a result of a discriminatory attack carried out by the Thai armed forces during the Cambodia-Thailand border conflict in the area of Thmor Daun village, Kork Mon commune, Bantay Ampil district, Oddar Meanchey province. Later on, this afternoon, the delegation will also deliver humanitarian relief and supplies to displaced civilians currently taking temporary refuge at Wat Phnom Thmor Kombor, located in Por Chas village, Beng commune, Banteay Ampil district, Oddar Meanchey province.

It is worth noting that this mission stemmed from the outcome of the special meeting held on July 28, 2025, in Putrajaya, Malaysia, and the extraordinary meeting of the Cambodia-Thailand General Border Committee, GBC, was concluded on August 7, 2025, which reaffirmed the full implementation of the ceasefire agreement on July 28, 2025, in Putrajaya.

3:00 PM, August 10, 2025

Intervention by H.E. Pen Bona, Royal Government Spokesperson:

Today, as the spokesperson of the Royal Government of Cambodia, I would like to brief Cambodian citizens both at home and abroad, as well as the international community, as follows:

First: The peace-loving hearts of the Cambodian leaders and people, as well as those of the international community, are a strong foundation for sustaining the effective implementation of the ceasefire agreement. In other words, the Ceasefire Agreement is being implemented under the watchful eyes of peace-loving countries, including the Interim Observers Team, diplomatic missions, and foreign military attachés, especially under the observant eyes of the three countries that played a significant role in shaping the agreement, which are the United States, Malaysia, and China. The pilgrimage of 2569monks this afternoon in Phnom Penh City is a testament to Cambodia's peace-loving spirit.

Second: Cambodia reaffirms its unwavering commitment to respecting the ceasefire agreement and once again urges Thailand to fully honor the ceasefire agreement reached on 28 July 2025 in Putrajaya, as well as the outcomes of the recent Extraordinary Meeting of the Cambodia—Thailand General Border Committee (GBC) on 7 August 2025 in Kuala Lumpur, particularly the agreement to maintain their current troop deployments and refrain from patrols toward the other side's positions.

Third: To all Cambodian citizens, both at home and abroad, please remain calm and do not fall for the tricks of fake news or old information that are posted, aiming to deceive public opinion, especially the Thai people. And, with a strong sense of solidarity, please continue to trust in the government and its leadership, in the Ministry of National Defense, and in our heroes of the army and armed forces in defending our territorial integrity.
