Press Briefing - Update on the implementation of the immediate and unconditional ceasefire agreement between Cambodia and Thailand

7:00 AM, August 24, 2025

Keynote Address by H.E. LTG. Maly Socheata, the Ministry of National Defense Spokesperson:

This morning I would like to provide some updates following the coming into force of the ceasefire between the Cambodian and Thai Armed Forces on July 28, 2025, and after the Extraordinary Meeting of the GBC was concluded on August 7, 2025, as of today:

1. Starting from 12:00 AM midnight on 24 August 2025 up to 6:00 AM this morning, the situation at the frontline, Military Region 4 and Region 5—Preah Vihear, Oddar Meanchey, and Banteay Meanchey Provinces—remains calm and steady under the control of our military forces. Cambodian military forces stand strong and remain fully vigilant in defending the country, sovereignty, and territorial integrity. The Cambodian Armed Forces firmly respect and strictly implement the ceasefire reached on 28 July 2025, as well as the 13-point Agreed Minutes adopted at the Extraordinary Meeting of the Cambodia-Thailand General Border Committee (GBC) on 7 August 2025, under the observation of Malaysia, the United States of America, and the People's Republic of China.

2. I would like to inform you that there have been great developments, particularly since the special meeting held on July 28, 2025, in Putrajaya, which resulted in the ceasefire agreement between the two countries and the fruitful conclusion of the extraordinary meeting of the General Border Committee (GBC) on August 7, 2025, and this was proven by the adoption of the 13-point Agreed Minutes.

This positive outcome clearly demonstrates that Cambodia and Thailand have collaborated constructively and keep positively progressing through, for example, the holding of the Extraordinary Meeting of the Regional Border Committee (RBC) between Cambodia and Thailand military regions; namely the extraordinary RBC meeting between Cambodia Military Region 3 and the Thailand's Chanthaburi-Trat Border Defense Commandment, held on August 16, 2025; and the meeting between Cambodia

Military Region 5 and the Thailand Commandment of the 1st Army Area, concluded on August 22, 2025. This meeting was concluded with clear confirmation of the commitment from both parties to respect and implement the ceasefire, as well as to inform to improve the border situation and bilateral relations for mutual benefit.

According to the program agreed by both sides, the Secretariat Meeting of the Cambodian-Thailand Regional Border Committee (RBC), between Cambodia Military Region 5 and the Thailand Commander of the Chanthaburi-Trat Border Defence Command, will be held today in Pailin Province with Cambodia as the host. It is anticipated that the meeting will yield positive outcomes, encouraging both parties to fully and effectively implement the ceasefire, which will lead to peace, stability, and the restoration of relations between the two nations at the soonest possible.

3. At the same time, Cambodia continues to call on the Thai side to implement the above agreements and return 18 of our military personnel to Cambodia so they can reunite with their families, who have been waiting day and night for their return. It is also important to note that Thai soldiers illegally captured these Cambodian military soldiers immediately after the ceasefire took effect on the morning of 29 July 2025; as of 7:00 AM on 24 August 2025, their detention has lasted 25 days, 23 hours, and 10 minutes.

The Ministry of National Defense, the Royal Cambodian Armed Forces, and the International Community will continually demand that Thailand uphold its obligations

under international law, and we wish to underscore that we will never abandon or leave any one of our family members isolated.

Full implementation of the ceasefire by both sides will create a favorable atmosphere for restoring peace, stability, and normalcy to the relationship between our two countries.

This is not only something that our two people aspire, but also it is the wishing of the whole world as clearly proven by the many messages of congratulations and support for the ceasefire agreement and the positive outcome of the Cambodia-Thailand General Border Committee Extraordinary Meeting.

Cambodia is committed to working constructively, sincerely, and in close cooperation with Thailand, Malaysia, other ASEAN member countries, as well as relevant partners, such as the United States of America and the People's Republic of China, to ensure the effective and full implementation of the ceasefire and to resolve disputes peacefully and in accordance with international law, the UN Charter, and the ASEAN Charter. The Royal Government, the Armed Forces, and the Cambodian people stand firmly united and resolutely determined to defend our territorial integrity, national sovereignty, and dignity.

Press Briefing - Update on the implementation of the immediate and unconditional ceasefire agreement between Cambodia and Thailand

7:00 AM, August 24, 2025

Intervention by H.E. Pen Bona, Royal Government Spokesperson

Key points for Cambodian citizens—particularly journalists and social media influencers—to take into account:

Firstly, under the utmost attention of the top leaders, Samdech Thipadei Hun Manet, Prime Minister, as well as Samdech Techo Hun Sen, President of the Senate, the ceasefire implementation is progressing gradually with positive results that can be seen vigorously through the GBC and RBC meetings. Cambodia remains firmly committed to implementing the ceasefire agreement to reach a peaceful resolution of the border issue between the two countries, Cambodia and Thailand, and maintain peace for both countries and their peoples. It should be noted that the implementation of the ceasefire agreement is ruling under the international watchful eyes, especially those of the United States of America, the People's Republic of China, and Malaysia, as well as the foreign diplomats and military attachés in Cambodia who have been actively operating their mission continuously in border observations.

Secondly, the strength of the Khmer national unity is still resolutely maintained by Cambodian citizens both at home and abroad, who continue to raise the Khmer flag and their voices to defend the national sovereignty and territorial integrity with great admiration for the bravery of the soldiers and our armed forces who stand firm to protect the territorial integrity of Cambodia. The great solidarity and strong national unity that emerged from the true patriotic spirit of the Cambodian people made psychological warfare and the tactic of using fake news aimed at demoralizing the Cambodian people backfire instantly.

Thirdly, the Royal Government of Cambodia, led by the Cambodian People's Party, remains a strong guardian of peace, social and political stability, and macroeconomic stability, as well as protecting national sovereignty and territorial integrity, and is the most reliable and warmest support for the Khmer people under all circumstances.

Cambodian military forces stand strong and remain fully vigilant in defending the country, sovereignty, and territorial integrity. The Cambodian Armed Forces firmly respect and strictly implement the ceasefire reached on 28 July 2025, as well as the 13-point Agreed Minutes adopted at the Extraordinary Meeting of the Cambodia-Thailand General Border Committee (GBC) on 7 August 2025, under the observation of Malaysia, the United States of America, and the People's Republic of China.

2. The Secretariat Meeting of the Cambodia-Thailand Military Region Border Committee (RBC) between the Military Region 5 of Cambodia and the Chanthaburi-Trat Border Defense Command of Thailand was co-chaired by Major General Sar Kimpak, Head of the Cambodian Secretariat, and Captain Kittiphon Kunsiripanyo, Head of the Thai Secretariat. The meeting commenced at 9:25 AM and concluded at 2:00 PM on August 24, 2025, hosted by Cambodia, in Pailin Province, in accordance with the program agreed upon by both sides.

After the meeting commenced, both parties reviewed the detailed points to be included in the agreed minutes. Following the discussions, the Secretariat Meeting of the Cambodian-Thailand Regional Border Committee (RBC) between Cambodia's Military Region 5 and Thailand's Chanthaburi-Trat Border Defense Command proceeded with noteworthy significant positive developments in preparation for the upcoming Extraordinary Meeting of the Cambodian-Thailand Regional Border Committee (RBC)

between Cambodia's Military Region 5 and Thailand's Chanthaburi-Trat Border Defense Command scheduled for tomorrow, August 25, 2025. It is anticipated that the meetings would yield further positive results, allowing both sides to fully implement the ceasefire, restoring peace, stability, and normalcy to the relationship between the two countries.

3. Press Briefing – Update on the implementation of the immediate and unconditional ceasefire agreement between Cambodia and Thailand

4:00 PM, August 24, 2025

Keynote Address by H.E. Chum Sounry, Spokesperson for the Ministry of Foreign Affairs and International Cooperation (MoFAIC):

1. On Diplomatic Visit to Banteay Meanchey and Oddor Meanchey Provinces Led by H.E. Deputy Prime Minister PRAK Sokhonn:

On 22–23 August 2025, His Excellency Deputy Prime Minister PRAK Sokhonn, Minister of Foreign Affairs and International Cooperation, led a diplomatic visit with the participation of over 60 members of the diplomatic corps, representatives of United Nations specialized agencies, international organizations, and foreign non-governmental organizations working on humanitarian mine action.

The delegation visited affected areas in Banteay Meanchey Province, where barbed wire, barricades, and other obstacles laid by Thai military forces have prevented local residents from returning to their homes. The delegation also inspected the site of bomb explosions in Oddar Meanchey Province, including Wat PrasatTamone Sen Chey and the MK-84 bomb site in Thmor Doun village.

His Excellency Deputy Prime Minister PRAK Sokhonn reaffirmed the Royal Government's strong commitment to alleviating the hardships of affected families and ensuring their safe return, while making every effort to achieve a full and effective ceasefire.

The delegation expressed its firm expectation that complete peace and stability will be restored soon, allowing displaced Cambodian citizens to return to their homes in safety and dignity. It underscored that the full implementation of the ceasefire agreement remains a crucial step toward lasting peace and a peaceful resolution of the border issue.

2. Cambodia Welcomes Diplomatic Corps' Call to Uphold Ceasefire

The Ministry of Foreign Affairs and International Cooperation welcomes the Diplomatic Corps' appeal in favor of upholding ceasefire between Cambodia-Thailand as expressed during diplomatic visit in Oddor Meanchey Province on 22 August 2025.

Ambassador Extraordinary and Plenipotentiary of Japan, His Excellency UENO Atsushi, told the journalists in Oddor Meanchey Province on 22 August 2025 that:

- The Japanese government firmly supports the unconditional prompt ceasefire. Also, we (Japan) would like to provide support for the people affected.
- We (Japan) hope that this issue will be resolved through the peaceful dialog between two countries, not by fighting.

Ms. Bridgette Walker, Chargé d’Affaires of the United States Embassy in Phnom Penh, underlined in her interview with journalists in Oddor Meanchey Province on 22 Aug 2025 that:

- It is very helpful for us to have eyes on in the actual areas.
- President Trump and Secretary Rubio are very interested in seeing the ceasefire hold and have spoken with both the Cambodian and Thai governments and encourage and expect that each government in each country will uphold its commitments.

First Secretary and Deputy Head of Cooperation of the Delegation of the European Union to Cambodia, Mr. KOEN Everaert, told the journalists in Oddor Meanchey Province on 22 August 2025, that “EU encourages both sides to continue to hold the ceasefire agreements, as well as continued good communication from both countries in order to rebuild trust and stability in the border”.

In this connection, I would like to recall that His Excellency Deputy Prime Minister Prak Sokhonn, Minister of Foreign Affairs and International Cooperation, during a briefing held at the Ministry on 21 August 2025 and attended by 78 heads and representatives

of diplomatic missions, UN agencies, and NGOs, reaffirmed Cambodia's commitment to the ceasefire agreement reached between the two countries on 28 July 2025 in Putrajaya and the 13-point outcomes of the Cambodia–Thailand General Border Committee meeting on 7 August 2025 in Kuala Lumpur.
